Thank you for your interest in the *Downtown Oronoco Gold Rush Days, Inc.* held August 14, 15, and 16, 2009. The show is open from sunrise to sunset Friday, Saturday and Sunday (3:00 p.m. on Sunday).

### General Information

- *Downtown Oronoco Gold Rush Days Inc.* is an annual event with proceeds benefiting the City of Oronoco
- This show is an established outdoor antique venue with national recognition. Dealers from all over the United States converge to our show to buy and sell. There are an estimated 20,000 people daily who attend the event.

- Over 1200 lots are available for rent; 25 food booths; abundant portable toilets; on site security

### Registration

- Returning dealers have priority and have until May 15<sup>th</sup> to submit their applications. Lots that have not been reserved will be released to new vendors. Therefore, about May 1<sup>st</sup> new vendors, who have requested lot, will be sent an application and contract. Complete the reservation package and return all forms along with your payment. Lots are assigned on a first paid/received basis. Checks will be cashed immediately.
- Minnesota law requires a MN state tax number to participate in our show. A MN tax form **ST-19** is included with your package and must be returned with your reservation. Instructions are on the back of the form or call (651) 282-5225.
- A confirmation letter and detailed map will be mailed.

### Lot information

- All lots are outdoors and are approximately 15' x15' or 20' x 20', dependent upon location; rent is \$100 per lot. You may rent multiple lots if available. **Everything you bring must be contained within your assigned space. No exceptions!**
- Parking is available at a cost in parking lots around the City. **There is no free vehicle parking.** Vehicles will be towed if parked in undesignated parking spaces. You may park next to your lot for a very brief time during setup.
- You will be provided with an ID sign that must be displayed in your vehicle throughout the show.
- No spikes are permitted on paved surfaces; bring weights to hold canopies
- No free tables are provided.
- There is no electric or water available on your lot. Water is located at the Community Center located in Section D
- Your booth must be open until 3:00 p.m. on Sunday; if not, your lots will be forfeited for the next year's show.
- No food, pop, water or candy may be sold without a Food Vendor permit issued by the city.
- No fireworks, golf carts
- One way traffic patterns strictly enforced.
- An information booth located in Section A will be manned Friday and Saturday 6:00 a.m. to 5:00 p.m. Sunday 8:00 a.m. until closing. Phone number at Information booth: 507-367-2111
- Ice and T shirts are sold at the Information booth.
- You will be required to be off your lot by 5:00 pm on Sunday as volunteers begin at 6:00 p.m. cleaning the area. Your lot is to be free of debris when you leave on Sunday.
